IMPORTANT INFORMATION ABOUT HAVING AN ACCOUNT: To help fight identity theft of our members, federal law requires all financial institutions to obtain, verify and record information that identifies each person who opens an account. This means that when you open an account, we will ask for your name, address, date of birth, and other information that will allow us to identify you. We may also ask for some form of identifying identification.		
A security deposit of \$500.00 or twice the highest bill will be required for consumers with a poor credit rating. A \$300.00 deposit will be required for consumers with a moderate credit rating. The security deposit will be refunded, with interest, after 12 consecutive months of prompt payment. Pay history is periodically evaluated and additional deposits may be required.					
					Pre-Paid Billing A minimum balance of \$25 is required to initiate prepay. No additional deposits are required. Electric service is subject to immediate disconnection any time the
account does not have a credit balance. Medical conditions or inclement weather will not postpone disconnection.					Regulations also require that we obtain permission to contact you via cell phone for outage, billing and collection information, co-op sponsored surveys, or any other call or text to your cellular device that the cooperative deems necessary or important. By signing this document and giving us your cellular number, you are authorizing Central Rural Electric Cooperative to use this cellular device for automated calls and texts to notify you of this information. If, during the time of your service with Central, you no longer have the cellular number(s) given to us, you are responsible for informing the cooperative immediately of the change. At any time, you have the option of opting out of any calls to you.

When electric service becomes available, the applicant will purchase from the Co- operative all the electric energy for use on the premises, and will pay monthly at rates set forth by the Cooperative. In the event, the applicant does not utilize the minimum amount of kilowatt-hours set by the board of trustees, the applicant agrees to pay the minimum monthly payment.
